# Guidelines for the Formal Structure of Papers and Final Theses at the Chair of Digital Governance

#### Format

- 1.5 line spacing
- font size 12
- Times New Roman

#### Language

The language of the thesis should be communicated to the supervisor when requesting supervision approval. It is recommended to write in English.

#### Page count

A bachelor thesis is a maximum of **40 pages** of text (excluding sources and the appendix). A master's thesis is a maximum of **60 pages** of text (excluding sources and the appendix). When the thesis is written in scientific paper format, it can be shorter.

## **Citation style**

APA Style, 7th Edition. The manual is available <u>here</u>. Additionally, you can find sample papers <u>here</u>.



## Structure

The thesis requires:

- Cover page
- Abstract
- Table of contents
- if applicable, a list of figures and tables
- if applicable, a list of abbreviations
- text part
- Appendix
- Bibliography
- Declaration of Academic Integrity

## Appendix

Survey questions, interview questions, and code for analyses belong in the appendix. Code needs to also be sent along with the thesis via email (e.g., R code file).

## **Declaration of Academic Integrity**
